#### **Invitation for Expression of Interest (EOI)**

Project Management Unit (PMU) of West Bengal Forest & Biodiversity Conservation Project, funded by the Japan International Cooperation Agency (JICA) invites Expression of Interest (EOI) for conducting **Socio-Economic Baseline Survey** to ascertain socio-economic status of communities involved in the FPCs/EDCs involved in the Joint Forest Management in the state.

The modules and items that should be covered by baseline survey are as follows:

#### Household level

- General information about the household: (identification of the household, basic information on its composition and main characteristics including family composition, proximity to roads and markets, education, member of what kind of group or cooperative etc.)
- Income (per household)
- Structure of Income (Agriculture, Off-farm income, income from Forest Products and NTFP, Labour income, and debt etc.)
- Household assets (it can be one of the indicators of income)
- Income distribution of house hold
- Perception of the status of forest by comparing past and present

#### Community (or FPC/EDC) level

- Review and collection of all available information and sources
- Number of SHG or organizations which are active and their status of activities (Total transaction of last one year, actual deposit amount etc.)

#### **Coverage of Baseline Survey**

The survey would cover representative FPCs/EDCs falling in two batches, however, to have a comparative picture of changes in the non-project area (control) vis-à-vis project area, few FPCs/EDCS having more or less similar conditions would also be selected outside the project intervention areas but with the same district to be called 'Non-project FPCS/EDCs'. Around 15% of the FPCs/ EDCs in each district of the state should be considered for this baseline survey. There are around 4200 FPCs/ EDCs in the state of West Bengal.

**Bidder Profile /Pre-Qualification Criteria**: The main eligibility criteria for shortlisting the Firm /company /institution are:

#### **Technical Eligibility Criteria**

- 1. The firm/company/institution should have completed at least two similar consultancy assignments in last 5 years. The number of assignments for which 'Certificate of Satisfactory Completion of Assignment' has been obtained will only be counted as completed assignment.
- 2. The firm/company should have experience of working on similar assignment in externally aided projects.

#### Financial eligibility criteria

Demonstrated capacity of Financial Management:

The firm /company /institution should have the annual turnover of INR Twenty five lakh or more in each of the financial years, viz., 2011- 12, 2012-13, and 2013-14. It may be noted that certified copies of the Audited Balance-sheet summary should be attached for the indicated financial years. Tentative balance-sheet may be attached for 2013-14, in case audited balance-sheet is not available.

#### **Selection process**

On the basis of evaluation of EOI, firm /company /institution (not more than five) will be short listed. The Request for Proposal (RFP) along with the Terms of Reference (ToR) will be sent to the short listed firm /company /institution only. In addition to the submission of written proposals based on RFP, the shortlisted firm /company /institution are to give presentations of their proposals on a prescribed date and venue, at their own cost. The selection shall be based on the quality and cost based selection (QCBS) method, with eighty per cent weightage for the technical proposal and twenty percent weightage for financial proposal. The final selection shall be done by an evaluation committee of experts set up for this purpose.

#### Application Fees:

Non-Refundable Application Fee of Rs.2000/- (Rupees Two Thousand Only) in the form of Banker's Cheque / Demand Draft issued by any Indian Nationalized Bank drawn in favour of 'Chief Project Director, West Bengal Forest & Biodiversity Conservation Project ' and payable at Kolkata, West Bengal, India should be submitted with the EOI. Please note that the EOI which is submitted without the Application Fee will be rejected as non-responsive.
