Technical and Financial evaluation report of NIT no.WBFBCP/NIT-12(e)/2015-16

FOR APPOINTMENT OF INTERNAL AUDITOR FOR THE FINANCIAL YEARS 2015-16 & 2016-17.

The Final Result has been derived on the basis of Quality Cum Cost Based Selection (QCBS). The detailed procedure of selection has been mentioned in clause 12 of the NIT.

Ranking of the bidders (Clause 12.3 of the NIT)

Being QCBS, as per clause 12.3 of the NIT the ranking of bidders has been done on 80:20

= Technical: Financial as follows:

Total Score Secured = 80% of Technical score + 20% of Financial score

The bidder securing highest total score has been ranked 1st and selected for the assignment.

Evaluation of technical bids have been done by a committee constituted for the purpose and the result was uploaded in the website on 03.02.2016.

Financial Result sheet

The Financial Bids of the technically qualified (minimum of 60 marks) bidders have been evaluated as per the evaluation criteria mentioned below vide clause 12.2 of the NIT

- The total Financial score for evaluation of financial bids is 100.
- The list of Bidder has been ranked in ascending order (i.e.) the Bidder who quoted the lowest Value (L1) has been ranked first and assigned 100 marks. Other bidders, viz: L2, L3 etc have been compared against the financial quote of the L1 and points assigned accordingly. For example, if the quote of L1 is 200 and that of L2 is 400, then L1 will be awarded 100 points (maximum) and L2 will be awarded $(\frac{200}{400}) \times 100 = 50$ points.

Given below is the Financial Scores of tenderers.

- L1- M/S Mukherjee, Biswas & Pathak Rate quoted- 3,94,250/-- Marks-100 = Actual 20%= **20.00**
- L2-M/S S.K.Agrawal & Co Rate quoted- 6,49,100/- Marks 60.74 = Actual 20%= **12.15**
- L3- M/S Om Kejriwal & Co Rate quoted- 6,85,000/- Marks 57.55 = Actual 20% = **11.51**
- L4- M/S J.Singh & Associates Rate quoted- 11,40,000/- Marks 34.58 = Actual 20%= **6.92**
- L5- M/S Sarkar Gurumurthy & Associates Rate quoted- 11,73,937/- Marks 33.58 = Actual 20%= **6.72**

Final Result on the basis of QCBS (80% Technical: 20% Financial)
