**MINUTES OF THE 6TH MEETING OF THE GOVERNING BODY OF WEST BENGAL
FOREST AND BIODIVERSITY CONSERVATION SOCIETY,
HELD ON 10TH JUNE, 2015**

The 6th meeting of the Governing Body of West Bengal Forest and Biodiversity Conservation Society was held on 10th June, 2015 at Aranya Bhawan. The quorum for the meeting was complete with the following members present.

The detailed agenda note was distributed to all the members well in advance. The members deliberated upon each agenda item and the following decisions were taken:-

1. **Confirmation of the minutes of the 5th meeting held on 27th November, 2014.**
The Secretary of the Society presented that no comments or observations have been received from any of the members and therefore the minutes may be taken as confirmed.

Decision: *The minutes of the 5th meeting of the Governing Body held on 27th November, 2014 are confirmed.*

2. **Discussion on the Action Taken Report on the Resolutions of the 5th meeting held on 27th November, 2014.**

The Action Taken Report attached as Annexure-I to the agenda notes was placed for deliberations. Discussion was centred on the points where follow up actions need to be taken. Decisions taken on each of the points are given below:

i. **Sl no.2 (i) of the ATR presented in Annexure-I of the Agenda note –
Modifications in the Composition of the Governing Body**

It was proposed that, though it was decided in the 5th meeting that the revision of the Governing Body should be presented in the next meeting, a Committee should be formed to suggest modifications in the Governing Body composition.

Decisions:

- (i) Constitution of a Committee to propose the revision of the composition of Governing Body is not required.
- (ii) The composition of the Governing Body should be as follows:

- (iii) The revision would be notified by the Forest Department.

ii. **Sl no.2 (iv) of the ATR presented in Annexure-I of the Agenda note — Regarding exemption of Income Tax**

It was presented before the members that the application for exemption of Income Tax u/s 12A has been filed on 30.11.2014 as decided in the last meeting of the Governing Body and further developments are awaited.

Decision:

The matter should be followed up.

iii. **Sl no.2 (v) of the ATR presented in Annexure-I of the Agenda note – Regarding regarding engagement of additional personnel on contractual basis**

The members were informed that the engagement of additional personnel on contractual basis, restricted to 15 or 16, for the PMU and field formations will be done in F.Y 2015-16.

Decision:

The Governing Body advised that the engagement of additional personnel on contractual basis for PMU and the field formations should be restricted to 16, instead of '15 to 16' as recorded earlier.

iv. **Sl no.2 (vi) of the ATR presented in Annexure-I of the Agenda note – Regarding Approval of Manuals and Guidelines**

The members were apprised that a Committee constituted for the purpose comprising senior officers of the Forest Directorate approved the Manual/Guidelines for preparation of Microplan, The Manual/Guideline for preparation of the Forest Dwellers Development Plan, The Guidelines for TPOFA and Manual on Nursery Techniques—Establishment of Infrastructure were finalised with minor modifications. Members were also apprised that major changes were suggested by the Committee for the Manual on Nursery Techniques—Production of QPM and the same will be done in consultation with the Forestry Expert during his next mobilization in June 2015.

Decisions:

- (i) *The action taken for finalisation of the four Manuals as stated is approved.*
- (ii) *Action proposed to be taken for revision of the Manual on Nursery Techniques—Production of QPM is approved.*

v. **Sl no. 9 of the ATR presented in Annexure-I of the Agenda note – Regarding Common User Group (CUG) facility**

In the 5th meeting the Governing Body approved the proposal of providing the CUG facility to the project implementers in principle. The matter was taken up with BSNL and Airtel, being service providers. However, they could not provide any pre-paid package and the feedback from Uttarakhand on the management of the facility is not encouraging. It was presented that the proposal of providing CUG facility may be considered dropped and instead possibilities of installing video conferencing facility for connecting the field units with headquarter may be explored. The PMU has already taken preliminary action in this line.

Decision:

The Governing Body appreciated the position and decided that

- (i) the proposal of providing CUG facility may be dropped;*
- (ii) the PMU may explore the possibilities of installing video conferencing with service providers like BSNL and IRCTC.*

3. Presentation of Status Report of WBFBC Project.

The Status Report of WBFBC Project attached as Annexure-II to the agenda notes was presented item wise through a power point presentation. Few clarifications sought by some of the members of the G.B were explained to their satisfaction. It was also clarified that the PMC is already in the process of taking circle wise review meetings with the Circle incharge, the Head DMUs and the Head FMUs under them to put thrust to improve the implementation.

Decision:

The Governing Body took serious note of the shortcomings in the implementation of the project components and decided the following:

- (i) Since there is a substantial shortfall in the submission of the microplans (which is one of the main pre-requisites for implementing programmed works) the PCCF General will follow it up with individual DMUs to improve the situation, in addition to the pursuance by the PMU authorities.*
- (ii) Quarterly review of the progress of WBFBC Project implementation at PCCF level and monthly reviews by Circle incharges should be taken.*
- (iii) The PCCF Gen may devise a mechanism so that the performance of the FMU and DMU heads in implementation of WBFBC Project is reflected in their ACRs/PARs.*
- (iv) The DMUs, excluding the recent additions, not performing satisfactorily, will be identified by the PMU and separate meetings will be taken by the concerned PCCFs within a short time.*

4. Appointment of Auditor for the Accounts of the Society for the year 2014-15.

As per the approval of the Governing Body in its last meeting, M/s J. Singh and Associates, the lowest bidder, was appointed for Statutory Audit of Financial Accounts of the Society for the year 2013-14. The rate quoted by M/s J. Singh and Associates was Rs. 7,500/- excluding taxes. Actual travel expenses would be charged extra. The above rates are effective for one year, i.e. upto July 2015. The members were informed that M/s J. Singh and Associates has expressed their willingness to take up the audit of the Society for the year 2014-15 at the same rates. The matter was placed before the Governing Body for approval.

Decisions:

- (i) The engagement of M/s J. Singh and Associates, for Statutory Audit of Financial Accounts of the Society for the year 2014-15, is approved*
- (ii) The engagement of the statutory auditor should be under the same terms and conditions under which they were engaged for statutory audit for 2013-14.*

5. Approval for Annual Plan and Budget for the year 2015-16

The following facts and figures were presented before the members for approval of the Annual Budget 2015-16.

- Targets for 2015-16, as per Project document are as follows:
- Non-Reimbursable Portion — Rs 1275.70 lakhs and
- Reimbursable Portion — Rs 7864.90 lakhs
- Total Target — Rs 9140.60 lakhs
- Grant received by the Society during 2012-13 — Rs. 135.25 lakhs
- Grant received by the Society during 2013-14 — Rs 5508.00 lakhs
- Total Grant received by the Society — Rs. 5643.25 lakhs
- Total utilization of grants till 2014-15 — Rs. 2254.22 lakhs
- Opening balance of fund in 2015-16 — Rs. 3389.03 lakhs.

This unspent fund has also to be spent during the year 2015-16.

The Project is running almost 2 years behind schedule. The members were therefore requested to consider the budget provisions of 2014-15 of MoD for the year 2015-16 for implementation.

The targets for 2014-15, as per Project document are as follows:

- Non-Reimbursable Portion — Rs 1016.20 lakhs and
- Reimbursable Portion — Rs 6400.00 lakhs
- Total Target — Rs 7416.20 lakhs

It was proposed that the Revised Estimate for the year 2015-16 be limited to Rs. 7416.20 lakhs in place of Budget Estimate submitted as Rs. 9140.60 lakhs (as per MoD).

The members were apprised that the detailed Annual Plan for the year 2015-16 has been prepared taking into consideration the unutilised balance of Rs. 3389.03 lakhs and releases to be received during 2015-16 against the Revised Estimate of Rs. 7416.20 lakhs and is attached as Annexure III to the agenda notes, for the approval of the GB.

Decisions:

- (i) *The proposed Revised Estimate of 2015-16 amounting Rs 7416.20 lacs, presented in Annexure – III of the Agenda Notes, is approved*
- (ii) *The PMU is authorized to spend the unspent amount of Grants-in Aid during the year 2015-16.*

The Approved Annual Plan for the year 2015-16 prepared taking into consideration the unutilised balance of Rs. 3389.03 lakhs and releases to be received during 2015-16 against the Revised Estimate of Rs. 7416.20 lakhs is attached as **Annexure I** to these minutes.

6. Approval for deviations of Accounting Procedure

The members were apprised that there have been some minor deviations of the accounting procedure, which is new to the implementing units. The deviations observed against para 10.10.1. vi and para 10.11.x of the Operation Manual are given below:

- (a) Few DMUs have initially booked expenditure following the departmental procedure of Accounting and have given advances to the Head of DMU through bearer cheques. As per provisions of para 10.10.1.vi DMUs should release funds to FMUs/ individuals / JFMCs /EDCs through crossed cheques/ drafts against requisitions received from the FMUs.
- (b) Some of the DMUs have made cash payments in excess of Rs. 2500/- by mistake, against purchases or bill payments, though as per the provisions of para 10.11.x of the Operation Manual, purchases or payments in excess of Rs 2500/-, except payment to labourers through muster roll, should be made through account payee cheques.

The members were requested to consider authorizing the Project Director Finance to condone such deviations.

Decision:

The Project Director Finance, WBFBC Project is authorized to condone the deviations of the accounting procedure during 2014-15.

7. Delegation of power to prescribe various forms for Accounts of the Society

It was pointed out that the G.B in its 4th meeting held on 10.04.2014 had authorised the Project Director, Finance (Agenda item no. 15) to approve the creation or modification of a Head of Account without modifying the fabric of the approved Accounting Procedure. Accordingly a Chart of Account (COA) has been prepared and put to use in Accounting System. The Accounting Procedure of the Society has prescribed a number of Forms to be maintained for the purpose of compilation of the Accounts of the Society. However, with the changing requirements for project implementation, these forms need to be modified, added or deleted. This is a continuous process.

It was proposed that the Project Director, Finance may be authorised to approve the addition / deletion of forms or modification of prescribed forms without modifying the fabric of the approved Accounting Procedure

Decision:

The Project Director Finance, WBFBC Project is authorized to add / delete forms or modify the prescribed forms without modifying the fabric of the approved Accounting Procedure.

8. Operation of Account(s) of the Society.

The present system of operation of accounts of the Society is based on the Governing Body's decision authorizing any two of the following officers – Shri Subrat Dhaundyal, Addl. Principal Chief Conservator of Forests, Project Director, WBFBC Project, Shri Siddhartha Barari, Chief Conservator of Forest, OSD Special Projects and Shri Saurabh Chaudhuri, Conservator of Forests, Parks & Gardens Circle, to operate the bank accounts of the Society.

The Governing Body was apprised, that presently Addl. Project Director, Implementation who has been appointed on deputation to the Society, assists Project Director Finance and is entrusted to supervise the works of the Chief Accounts Officer (CAO) as per the Operation Manual of the Society. In absence of the CAO, the works of the CAO have been entrusted to a retired officer in the ranks of Deputy Conservator of Forests, engaged on contractual basis.

It was proposed that the Bank Account(s) of the Society may be operated by **any two** of the following officials, holding the charge of the following posts at any time -

- a) Project Director, Finance
- b) Addl. Project Director, Implementation
- c) Chief Accounts Officer (CAO)/Joint Project Director, looking after the works of CAO

Decision:

The operation of bank account(s) of the Society will be done by any two of the following designated officers:

- a) Project Director, Finance
- b) Addl. Project Director, Implementation
- c) Chief Accounts Officer (CAO)/Joint Project Director, looking after the works of CAO.

9. Approval for Selection of FPCs/EDCs

The Governing Body was apprised about the present status of selection of FPCs/EDCs. It was informed that as per the approved criteria selection for the 1st & 2nd batches was carried out as per the data provided by respective DMUs and approved by the GB in its 3rd meeting held on 01.09.2013.

Subsequently, the DMUs conveyed that there would be some changes in the available area for plantation/Coppice in a number of FPCs selected in the two batches. As the availability of area for plantation is the main criteria on which a FPC qualifies for the selection, the final selection of FPCs was deferred till the revised lists of FPCs showing corrected area for plantation were received.

The revision in respect of all DMUs have now been received. The revision of data on FPCs has also lead to discrepancies in scores secured by the FPCs already selected in the first two batches. This has also resulted in either elimination or change in ranking of a few FPCs in a Division. The scores secured by an individual FPC in the final process have been taken as final. The combined list of 530 FPCs (453 in South Bengal and 77 in North Bengal) and 29 EDCs attached as **Annexure-IV** to the agenda notes, was placed before the Governing Body for approval. The selection of FPCs/EDCs will be considered as complete only when the Micro-plans of all the FPCs/EDCs are completed.

Decision:

The FPC list comprising 530 FPCs (453 in South Bengal and 77 in North Bengal) and 29 EDCs, attached as Annexure-IV to the agenda notes is approved.

The FPC list comprising 530 FPCs (453 in South Bengal and 77 in North Bengal) and 29 EDCs, is attached as **Annexure-II** to these minutes.

10. Procurement of additional Root Trainers of 150 cc and 300 cc capacity.

In the 5th meeting held on 27.11.2014 the Governing Body had approved procurement of 20 lakhs 150 cc and 20 lakhs 300 cc root trainers with financial approval of expenditure of Rs. 1,53,40,000. Accordingly, during 2014-15, procurement of 20 lakhs root trainers of 150 cc and 20 lakhs root trainers of 300 cc capacities was completed by different DMUs from M/S Rajdeep Agro Products Pvt. Ltd., N. Delhi, and M/S Global Traders, Kolkata respectively, who were selected through the e-tender process by the PMU. The rate for 150 cc root trainers was Rs. 2.93 each and that of 300cc root trainers was Rs. 4.74 each (inclusive of all charges such as VAT, transport, surcharge etc.).

However, estimation of requirement of root trainers based on the nursery capacities show that additional quantum of about 18 lakhs root trainers of 150 cc and 8 lakhs root trainers of 300 cc capacities would be necessary. Out of this requirement, about 3 lakhs root trainers of 150 cc and about 3.5 lakhs root trainers of 300 cc capacity are immediately required for production of QPM, especially Sal, during the overlapping period (April-June,2015) in a number of Central Nurseries.

The Governing Body was therefore requested to decide on the following:

- (a) Since the procurement of root trainers through e-tender takes considerable time and it had also failed a number of times earlier, supply of additional 4 lakh root trainers of each capacity may be granted from the same suppliers who have submitted the lowest rates.
- (b) Accord financial approval of Rs.30,68,000.00 for the procurement of additional 4 lakhs of 150 cc and 4 lakhs of 300 cc root trainers, in addition to the financial approval of Rs.1,53,40,000.00 already granted earlier for the supply of 20 lakhs 150 cc and 20 lakhs 300 cc root trainers.

Decision:

- (i) *Procurement of additional quantities of 150 cc and 300 cc root trainers to the tune of 4 lacs nos. of each capacity is approved. The procurement will be done from M/s Rajdeep Agro Products Ltd. and M/s Global Traders at the same rate and terms and conditions.*
- (ii) *The financial approval of Rs. 30,68,000.00 for the procurement of additional quantum of 4 lacs nos. each of 150 cc and 300 cc capacity is granted.*

11. Repairs of frontline staff's quarters

Though repairs to the quarters of frontline staff is an urgent requirement, the fund that can be provided from the normal budget of the Directorate for this purpose is limited. The Governing Body in its 4th meeting held on 10.04.2014 had decided to utilise a part of the interest earned by the Society on unutilised amount for this purpose. About 400 quarters of the frontline staff were approved in the initial stage at a flat rate of Rs. 30,000.00 each.

During 2014-15, allocations to the tune of Rs. 71,62,000 were made to DMUs for the repairs of 238 quarters of the frontline staff who are basically engaged in the implementation of the Project. A total of 204 quarters have been repaired with utilization of Rs. 61,19,000 during the year 2014-15 and the expenditure has been booked under the Non-reimbursable part of the Project in place of booking it against the interest earned part. JICA has also expressed its agreement for admitting this activity as non-reimbursable component of the Project.

It was proposed that about 250 quarters may be taken up for repairs during the year 2015-16 at a fixed rate of Rs. 40,000 each unit instead of Rs 30,000 each unit approved earlier. This will require about Rs. 1.0 crores for the purpose. The funds are available for this activity under Non-reimbursable part of the Project.

Decisions:

- (i) *The proposal of repairs to 250 frontline staff quarters in 2015-16 is approved.*
- (ii) *The proposed rate for the repairs of Rs.40,000 each unit is approved.*
- (iii) *The total expenditure for building repairs should be limited to Rs. 1.0 crore.*
- (iv) *The expenditure should be booked under the Non-reimbursable part.*

12. Administrative & Financial approval for Construction (extension) of building at Aranya Bhawan, Salt Lake, Kolkata

The G.B in its 5th meeting, held on 27.11.2014, had accorded revised financial approval of Rs. 3,00,00,000 (Rs. Three crores) only for extension of two floors of Aranya Bhawan under the project. The total area of expansion in the additional two floors is approx. 14400 sft.

The PMU has received a further revised estimate of Rs. 3,19,57,762.00 only from the PCCF (Gen) for the work, since there has been a revision of the estimate due to inclusion of the works of Internal Wirings.

The total amount of the revised estimate is within the budgeted cost when escalation is taken into consideration.

The e-tender for the work was floated by the DCF, Admin., vide notice no. DCF/ADMIN/JICA/NIT-(e)-2 of 2015-16, against which three valid bids were received. All the three bidders were declared as "technically qualified" based on evaluation. The rates quoted by the three bidders are shown below, based on the Financial bids, opened on 28.05.2015.

The Governing Body was requested to:

- accord financial approval, post facto, for the revised estimate of Rs. 3,19,57,762.00 (Rupees Three crore nineteen lakhs fifty-seven thousand seven hundred sixty-two) only for the said Project;
- approve the issuance of e-Tender for the said project post facto.
- approve and accept the lowest rate quoted by Krishna Enterprise @ 9.57 % below estimated rate, amounting Rs.2,88,97,794.00 for the work;
- authorise Chief Project Director to accord approval for signing the contract with the successful bidder and to issue work order, through PCC (G).

Decision:

- The revised estimated cost of Rs 3,19,57,762.00 (Rupees Three crore nineteen lakhs fifty-seven thousand seven hundred sixty-two) only for the project is approved.*
- Issuance of e-tender is approved.*
- The lowest rate quoted by M/s Krishna Enterprise @9.57% of the estimated cost of the project, which amounts to Rs 2,88,97,794 (Rupees Two Crore Eighty Eight Lakhs Ninety seven thousand Seven hundred Ninety four) only is accepted.*
- Chief Project Director is authorized to accord approval for signing the contract with the successful bidder and to issue work order, through PCCF (G).*

13. Modification in desirable qualifications for Extension Workers

Para 77 of Annex II of the MoD prescribes that extension workers shall be hired from the project villages to support undertaking various activities by JFMCs/ EDCs such as record keeping, accounting etc. The payment for these workers shall be borne by the Project during the Project implementation period. There will be one extension worker per 5 JFMCs/ EDCs. The required qualification for extension worker shall be young (preferably within 30 years of age), an active member of JFMCs/ EDCs and be at-least class 8th pass. After the Project completion, JFMCs/ EDCs may continue services of extension workers on their own cost.

The Operation Manual of the Society specifies, vide para 2.19, that the suitable eligibility criteria, selection procedure, quantum and method of remuneration, performance appraisal etc. would be decided by the PMU for Extension Workers.

The Operation Manual of the Society also specifies, vide para 2.19.1, the duties and functions of extension workers.

The selected EW is expected to broadly perform the following functions:

- i. To communicate and coordinate with various participating agencies including functionaries of forest department, officials of other line department and agencies as well as the eminent people of the area
- ii. To keep and maintain the records and other documents of the JFMC/EDC
- iii. To facilitate easy communication with JFMC/EDC
- iv. To motivate JFMC/EDC members for better management of project activities as well as better management of resources of the village
- v. To inform the forest officials about any act of violation of forest rules and regulation in the village.
- vi. To assist Forest Department in preventing damage to forest and wildlife.

It was proposed that the essential and desirable qualifications of the EW may be amended as follows:

Decisions:

- (i) *The proposed amendment of the educational qualification of the Extension Workers from Class VIII pass to Class XII pass is approved.*
- (ii) *Addition of desirable qualification of knowledge of working with computers / commercial accounts is approved*

14. Inclusion of Revision of target areas under the Project

The activities under the WBFBC Project have been spread almost all over the districts and Divisions in the State. Some wings or Circles or Divisions which have many other sources of funds from other Projects, were finding it either difficult to take up the activities under yet another Project (WBFBCP in the instant case) or were finding the targets too meagre to devote time and resources on it. One such case is that of Buxa Tiger Reserve (BTR). The Tiger Reserve gets funds under a number of Projects, financed by both State and Centre, and does not have the manpower resources to take up the additional activities under the WBFBCP. As a result of this, the funds (to the tune of Rs. 62.92 lakhs) allocated to BTR in 2013-14 remained unutilised till 31.03.2014. The Governing Body, in its 4th meeting held on 10.04.2014, therefore approved, vide decision against agenda item no. 10, that the Project activities may not be implemented in the areas under the two DMUs of BTR and the targets may be allocated to other Circles in the North Bengal. The above decision was subject to the final acceptance by JICA.

The proposal to this effect has already been submitted to JICA and is awaiting its approval.

As per the decision of the GB, possibilities were explored to re-allocate the targets of BTR to some other DMUs.

The availability of plantable area within selected JFMCs has been a limiting factor in most of the DMUs. The PMU has selected 530 FPCs and 29 EDCs in the designated FPCs. There is scope for selection of further 20 FPCs and 21 EDCs under the Project.

It was proposed that the balance FPCs may be selected and redistributed to different DMU.

Decisions:

- (i) *The selection of 530 FPCs and 29 EDCs is already approved under agenda item no. 9 of the meeting.*
- (ii) *Selection of remaining 20 FPCs and 21 EDCs may not be done at present.*

The approved distribution of selected FPCs and EDCs is attached as **Annexure-III** to these minutes.

The meeting ended with vote of thanks to all the members of the Governing Body.
