West Bengal Forest and Biodiversity Conservation Society <u>Minutes of the 10th Meeting of the Governing Body</u>

The 10th meeting of WBFBC Society was held on 19th January, 2017 at Aranya Bharavn Conference Hall on 6th floor.

The meeting was chaired by **Shri C. Sinha**, Chairperson of the Society. The following members were present:

Shri P.T Bhutia, APCCF North Bengal, Shri N.V.Rajasekhar, APCCF HRD and Smt. M. Bandopadhyay, Addl Secretary Forest Dept. took leave of absence. The agenda wise comments mailed by Shri Bhutia were considered in the meeting. The Chief Project Director, WBFBC Project & Member Secretary of the WBFBC Society presented each item of the agenda following which discussions were made. The Agenda wise presentation and decisions taken are given below:

Confirmation of the minutes of the 9th meeting held on 16th June, 2016
 The matter was placed before the GB for confirmation.

Decision:

The minutes of the 9th GB stands confirmed.

Action:

No action required

2. Discussions of the Action Taken Report (ATR) on the Resolutions of the minutes of the 9th meeting held on 16th June, 2016

The Action Taken Report placed in Annexure 1 of the agenda note was presented before the G.B point by point and discussed. The following points were mentioned before the GB for their acceptance

(i) Against sl 5 (iii) of ATR it was mentioned that training of 30 Extension workers, 120 FPC members and 50 Frontline staff on microfinancing has been completed at BRAIPRD, Govt of W.Bengal, at Kalyani. Further training will continue.

The members were also informed that the CEO WBSRLM, Govt. of West Bengal has proposed a long term partnership for capacity building and livelihood enhancement of SHG women. They have also allowed WBFBC Society to use relevant portion of their manual on SHG management for publishing similar handbook in Bengali for the purpose of the project.

(ii) Against sl. 9 of ATR it was mentioned before the GB that the National Workshop was successfully organized through the Project Management Consultants very

recently. Also the likely expenditure would be around Rs 60 lacs against the approved budget of Rs 80 lacs.

Decision:

The Action Taken Report was accepted by the members.

Action:

No action required.

Presentation of the Status Report of the WBFBC Project
 The status report upto 31.12.2016 given in Annexure II was discussed

Decision

Members appreciated the achievement in training and accepted the Status Report

Action:

No action required.

4. Confirmation of the Circular Resolution—Acceptance of bid for selection of agency for wildlife research through e-tender

Resolution no.2 dt 24.11.2016 with regard to Acceptance of bid for selection of agency for wildlife research under the Biodiversity Conservation component was circulated to the members of G.B with a note by the CPD WBFBC Project, which mentioned that four bids were received against e-tender (2nd call) for Study on Ecology of Tiger in North Bengal. The final result was presented in a table which showed that Aranyak, secured 1st position as evaluated by the Evaluation Committee through QCBS (Technical 80 : Cost 20) method. The quoted rate of Aranyak is Rs. 54,73,710/- (Rupees Fifty four lakhs Seventy three thousand Seven hundred ten) only

Since as per the Delegation of Financial Power under the Operation Manual of the Society the limit of the CPD is Rs. 50.00 lakhs only the proposal was circulated for acceptance by the members of the G.B. Majority of the members agreed with the following resolution. This includes Addl PCCF North Bengal who has send his views through mail.

"Resolved that the offer of Aaranyak @ Rs.54,73,710/- (Fifty four lakhs Seventy three thousand Seven hundred ten) only inclusive of all taxes, for the purpose of study on Ecology of Tiger in North Bengal is accepted".

Decision

G.B confirmed the acceptance of the offer of Aaranyak as mentioned in the Circular Resolution and quoted above.

Action

PMU may formally inform PCCF Wildlife.

- 5. Amendment of provision of operation of Bank account of JFMCs
 - Following was placed before the GB that as per para 10.12: of Operation Manual of the Society:
 - (i) At JFMC / EDC level, existing savings bank account should be used for operating the 'Community Development Fund' for development of Community Infrastructure and allied activities. However the existing accounts of many selected FPC/EDCs, which are not under FDAs, are not jointly operated by Beat Officer as Member Secretary.
 - (ii) A second savings bank account shall be opened as 'Revolving Fund' for Income Generation Activities in any Nationalised Bank or in the nearest Gramin bank.

However, in many FPC/EDC area, there are banks which are declared 'at par with Nationalized bank' by Finance Dept., in which the accounts may be opened if allowed by the Society

It was therefore proposed that Relevant portion of para 10.12 of the Operation Manual may be amended as proposed herein below

- (a) A separate account may be opened for 'Community Development Fund' management by the FPC/EDCs, where the <u>existing savings bank account</u> is not jointly operated by Beat Officer as Member Secretary. Such <u>new savings bank account</u> should be operated jointly by the Beat Officer as Member Secretary and a Member of Executive Committee duly authorized by the Executive Committee.
- (b) Savings bank account may be allowed to be opened in banks declared 'at par with nationalized bank' by Finance Dept., provided nationalized bank is not available in the FPC/EDC area.

Decisions

(i) No new account may be opened for handling Community Development fund.

(ii) Existing bank account (Savings or Current) of the FPC/EDCs should be used for operating the Community Development fund. The beat officer as Member Secretary of the FPC/EDC must be included as joint operator of such existing bank account in case it is not being done at present.

(iii) The revolving fund to be operated through a second bank account, should be jointly operated by the beat officer as Member Secretary of the FPC/EDC and a member of

the Executive Committee to be designated for the purpose.

(iv) PCCF HoFF West Bengal will issue an order with regard to decision (ii) and (iii) above.

(v) Fund for Community Development should be transferred to the FPC/EDC bank account from the DMU after the satisfactory completion of work.

(vi) The relevant provisions of the Operation Manual and/or Account Manual should be modified accordingly and notified by the PMU.

Action

(i) PCCF HoFF on decisions (ii) and (iii). PMU to draft the order for PCCF HoFF.

(ii) PMU to communicate with all DMUs on decision (v).

(iii)PMU to act on decision (vi)

6. Operation Manual and Accounts Manual—Proposed inclusion of provisions with regard to tax deduction by FPCs/EDCs

Para 7.3 of the Operation Manual provides for Method of Procurement by PMU, DMU and FMU. Procurement by FPC/EDC has not been included in the provisions. Since Community Development funds are likely to be spent for construction purpose or other items by the FPC/EDCs with value more than Rs 1.0 lakh, local tender has to be called by them. Concomitantly, deduction of TDS and/or Cess deposition of the same has to be done as per existing statute.

GB was apprised that since FPCs/EDCs are not registered bodies, deduction and deposition of TDS/Cess etc., will not be possible in tender works.

It was proposed that tender works at FPC/EDC level may be floated by the concerned DMU on their behalf and payment made by DMU to the contractor on satisfactory work completion certificate to be issued jointly by the Member Secretary of FPC and an Executive Committee member to be selected by the Executive Committee. DMU may deduct the applicable taxes and cess and deposit to appropriate heads.

Decision

GB considered the submission and decided that all decisions with regard to tender, quotation, deduction of taxes as per statute for the purpose of Community Development fund, may be decided by the Head of DMU.

Action

PMU to inform all DMUs about the GB decision.

7. Sanction of fund for Community Development works in DMUs.

G.B was informed that the Community Development works have already been initiated. Though it was directed to restrict to 50 FPCs to start with (9th meeting), preliminary training on microfinancing and community development held with the support of BRAIPRD, Kalyani, Govt of West Bengal, has been encouraging. It was therefore proposed that

- (a) Community Development work in about 150 selected FPCs instead of 50 FPCs as approved by GB in earlier meeting may be taken up;
- (b) Intensive microfinancing training through BRAIPRD, Kalyani, Govt of West Bengal will continue and release of fund for microfinancing will be done in phases to the FPC/EDCs.

The total DMU wise budgetary requirement in connection with Community Development and Microfinancing for IGA was placed in **Annexure III** for approval of the GB

<u>Decision</u>

- (i) Community Development in 150 selected FPCs (instead of 50 allowed earlier) is approved.
- (ii) Budget allocation for Community Development required to cover all FPCs (600 nos) to the tune of Rs 26,87,31,500/- only (as presented in Annexure III) is approved.
- (iii) Budget allocation for Microfinancing for IGA Activity (Revolving Fund) required to cover all FPCs (600 nos) to the tune of Rs. 7,50,00,000/- only (as presented in Annexure III) is approved.

Action

PMU on decisions (ii) and (iii)

8. Re-allocation of fund provided under wild life equipment of squad for purchase of wildlife squad vans.

Under the Biodiversity Conservation component of the project, one of the items of work is Procurement of Equipment. An amount of Rs.7.61 +3.5 = Rs 11.11 lacs including escalation and contingency has been provided for this item. During a discussion with PCCF Wildlife and CWLW on 16.12.2016, it revealed that fund for equipment for wildlife management is available from other fund sources and therefore the fund provided under the WBFBF Project for this purpose would be superfluous.

The PCCF Wildlife & CWLW vide his letter no. 6045/WL/2B-281/16 dt 29.12.2016 has therefore proposed, that the fund provided for procurement of equipment under Biodiversity Conservation may be utilised for procurement of 2 nos. of Special Utility Rapid Action Mobile Vans (Bolero Camper model) for mitigation of human-animal conflict. PCCF Wildlife has also requested to place the matter before the G.B for concurrence.

Members were requested to concur with the proposal above.

Decision

The proposal of the PCCF Wildlife and CWLW was approved by the GB.

Action

PMU for necessary action.

9. Diversion of fund for Maling Bamboo removal and afforestation to Grassland creation in PAs

Under the Biodiversity Conservation component, one of the items of work is Removal of Maling bamboo and creation of plantation in the PAs in hills. It is felt, since Maling bamboo exists in patches and not extensively in the PAs in the hills, creation of plantation after removal of Maling bamboo proposed under the model of Habitat management of PAs of North Bengal, may not produce any noticeable impact. PCCF WL considered the matter and suggested to

(i) discontinue the model of Creation of plantation after Maling bamboo removal

(ii) create grasslands with fodder trees in PAs to the extent possible, out of fund diverted from Maling Bamboo model, since this has given very positive impact.

The Addi PCCF North Bengal sent a note on this (in absentia) in which he requested to reconsider the suggestion of the CWLW of discontinuance of the Maling bamboo removal model of plantation creation and diversion of the fund to augmentation of grasslands in PAs.

Decision

Members considered the submissions and it was decided that

- (i) Model of Creation of plantation after removal of Maling bamboo should be discontinued.
- (ii) Diversion of unspent fund under the Maling Bamboo model to Creation of grassland and fodder trees in PAs of North Bengal is approved.

Action

PMU to revise the APOs accordingly and inform PCCF Wildlife and concerned DMUs.

10. Additional fund required for extension of Aranya Bhavan

The matter of providing additional fund of Rs. 90,00,000/- (Rupees Ninety Lakh) only for vertical expansion of Aranya Bhavan, including cost of replacing 18 yrs old elevators was discussed in the 9th meeting and the following decisions were taken:

- (i) the Grant of additional fund of Rs.90,00,000/- (Rupees Ninety lakhs) only for installation of new elevators in Aranya Bhavan is agreed to in principle.
- (ii) The mobilization of additional fund may be explored.

The GB was apprised that recently, PCCF (HoFF) West Bengal, vide his letter no. 8211/P&S(P)/3D-678/16(Vol-II) dt 9.11.2016 has informed the following:

- (a) Some civil work is required to be undertaken for extending the elevators to 8th floor presently under construction under WBFBC Project funding.
- (b) Since the elevator technology has improved in the last two decades, the three elevators operating at present need to be replaced with three new MRL Elevators extending upto 8th floor.
- (c) The total fund required for this additional work is to the tune of Rs 1,02,10,280/-(Rupees 1.021 Crores) only.

The members were informed that PCCF (HoFF) has requested to provide the additional fund, from either the interest accrued on fund deposited in the account of WBFBC Society, or from the non-reimbursable portion of the project fund. *Decision*

The additional fund of Rs 1.021 Crores required for additional civil work and replacement of elevators of Aranya Bhavan extension as proposed by the PCCF HoFF may be allotted from other similar projects budgeted under the Institutional Capacity Building, viz: escalation cost and contingency under Siliguri Administrative Building.

Action

PMU to act on the decision.

11. Filling up of vacant post in the PMU

The GB was presented with the latest position of the posts created within the WBFBC Project PMU and the vacancy position as shown below:

GB was requested to consider the following proposals

- (i) Shri Saurabh Chaudhuri, presently posted as PD M&E, may be posted as PD Finance against vacancy of Shri Soumitra Dasgupta, PD(Finance), transferred on deputation to MoEF. He may be relieved of his charge of PD M&E.
- (ii) Shri Kanailal Ghosh, who is in the rank of CCF and presently posted as APD P&R in the rank of CF, be posted as PD M&E (CCF) in addition to his own duties. A person of suitable rank may be posted as APD P&R.
- (iii) The GB may consider upgradation of at least one post in the rank of APD to the rank of CCF.

Decision

- (i) The Forest Department will take decision on the matter of filling up of vacant posts of PMU
- (ii) Regarding posting of JPD (HRD) and JPD (Extension) the Forest Department will be approached for the following modification of Notification No. 1162-For/G/6M-12/12 pt I dt 13.06.2014 where eight ex-cadre posts including the JPD(HRD) and JPD(Extn) were created:

"Officers posted as JPD(HRD) and JPD(Extn)will carry their own pay in their previous posting"

Action

No action with regard to decision (i). PMU to approach Forest Dept through proper channel.

12. Other items with the permission of the Chair

(1) Extension of contract period of Forest Ranger in PMU

The Governing Body in its 7th meeting held on 17th Nov, 2015, decided to engage Shri Badal Chakraborty, Forest Ranger (Retd) for a period of one year starting 1st November, 2015, as a special case, given his commendable service, alertness and fitness. The conditions of engagement of contractual staff imposed by the Governing Body, which are of relevance for extension of contract, were as follows:

- (a) Shri B. Chakraborty may be appointed on contractual basis through a fresh contract, presently for a period of one year starting 1st November, 2015, as a special case.
- (b) The extension of the contract will depend upon the quality of service he would deliver for one year.

In this meeting, the GB was requested to extend the contract period of Shri B.Chakraborty, Forest Ranger (Retd) for a further period of one year, since his performance in the past one year has been commendable. It was also placed for the consideration of the GB that Shri B.Chakraborty is very fit and alert to serve the Society.

Decision:

Considering the commendable service of Shri B.Chakraborty, Forest Ranger and his alertness and fitness the following decisions are taken

- (i) Shri B. Chakraborty, may be appointed on contractual basis through a fresh contract, presently for a period of one year, starting 1st November, 2016, as a special case.
- (ii) Further extension of contract will depend upon the quality of service he would be able to deliver during the current period of contract.

Action

PMU to take necessary action for appointment of retired FR.

(2) Expansion of Central Nursery units for tall seedlings

Some of the members including the PCCF General and APCCF Finance raised the issue of production of tall seedlings for the purpose of Sabujshree project and suggested that the 40 units of Central Nurseries created under the WBFBC Project may be utilised for raising the tall seedlings committed for the purpose.

Comments of the PMU

The GB was apprised by the PMU that most of the Central Nurseries created under the Project have space for expansion, but they are all root trainer based, which will be contrary to the polypot based nursery normally adopted for raising tall seedlings.

<u>Decision</u>

- (i) Expansion of Central Nursery units may be done for raising tall seedlings to be used for Sabujsree programme.
- (ii) PMU to give cost of infrastr for expansion only of the selected Central Nursery. Cost of production of seedling and its utilisation will be the responsibility of Forest Directorate.
- (iii) A meeting to be organised by PMU shortly in this regard and to submit report on the feasibility of the proposal by 31st Jan, 2017.

<u>Action</u>

(i) PMU to act on decisions (i), (ii) and (iii).

The meeting ended with a vote of thanks to the members and the Chair.
